Notification by a Member of Disclosable Pecuniary and Non-Pecuniary

PART A - PECUNIARY INTERESTS

NB - In accordance with Section 34 of the Localism Act 2011, a person commits an offence if, without reasonable excuse, they fail to register their pecuniary interests within 28 days of taking office or fail to update their register within 28 days of a change to their pecuniary interests.

The following disclosable **Pecuniary Interests** of myself, my spouse or civil partner or any person with whom I am living as husband or wife or any person with whom I am living as if we were civil partners.

(a) Any employment, office, trade, profession or vocation carried on for profit or gain.
